**OUR LITURGY FOR SUNDAY**—In today's Gospel, we hear the story of four men who bring one who is paralyzed to Jesus for healing. Unable to get through the crowd, they carry the paralyzed one to the roof, create an opening and then lower him, still lying on a mat, within reach of Jesus. Let us pray today for that kind of energetic faith.

**HOSPITALITY SUNDAY**—This Sunday is Hospitality Sunday. All are invited to Walden Hall after Mass for refreshments, each other's company and for the chance to look over the spiritual lending library.

**NO BIBLE STUDY THIS WEEK**—Because of President's Week, there will be no Bible Study on February 19-20. It will resume next week.

THE SEASON OF LENT begins on Wednesday, February 22 and continues until the Solemn Days of Holy Week. As we prepare for this penitential season, we invite everyone to attend the 7pm Mass on Tuesday evening to help us transition into the season of Lent. On Wednesday, Ash Wednesday, we will have morning Mass at 9am, a Prayer

Service at 12:10pm, an afternoon Prayer Service at 4:30pm and an evening Mass at 7:30pm. There will be the Imposition of Ashes at all the events of Ash Wednesday.

We encourage everyone to undertake some form of spiritual and penitential practice that is consistent with the Season of Lent. The "giving up" or the "doing something" extra is a decision that we should make for ourselves to focus upon during the entire season of Lent.

We have daily Mass at 9am. We will have Stations of the Cross every Lenten Friday at 7pm in the Church. We offer the Sacrament of Penance every Saturday at 4pm.

Let us pray for one another during the season of Lent.

### LENTEN GUIDELINES—

Fasting—On Ash Wednesday and Good Friday, those between the ages of 18 and 59 limit themselves to one full meal and eat nothing between meals. Those other meals are light meals.

Meatless Days—Those 14 years of age and over are to abstain from eating meat on all Fridays of Lent, as well as Ash Wednesday and Good Friday.

## LENT: FAST FROM; FEAST ON

Fast from judging others; feast on the Christ dwelling in them. Fast from emphasis on differences; feast on the unity of life. Fast from apparent darkness; feast on the reality of light. Fast from thoughts of illness; feast on the healing power of God.

Fast from words that pollute; feast on phrases that purify.

Fast from discontent; feast on gratitude.

Fast from anger; feast on patience.

Fast from pessimism; feast on optimism.

Fast from worry; feast on divine order.

Fast from complaining; feast on appreciation. MASS INTENTIONS FOR 2013—The 2013 Mass Book is available for reserving Masses for those who have died and also for the intentions of those who are living. When you come down to arrange Masses, please have your choices and intention names written down in case the Office is busy. This way we can arrange the Masses for you. The diocesan standard stipend for Masses, beginning in 2013, will be \$20 for a single Mass intention and \$15 for a Mass with multiple intentions. There are available dates for this year 2012 also.

REVERENCE WHEN RECEIVING THE EUCHARIST—We are asked to make a head bow as we approach to receive the Body of Christ and the Blood of Christ. Then we respond: "Amen" when we are presented with the Body of Christ or the Blood of Christ.

CATHOLIC MINISTRIES APPEAL 2012—Those of us on the diocesan mailing list should have received a communication from the CMA office about this year's Appeal. St. Thomas More has a goal or assessment this year of \$60,700. Again, we are asking everyone to consider making a pledge to the Appeal so that we can make our goal. Last year's CMA appeal returned over \$13,000 as a rebate to the parish. Every bit helps! Every pledge can be paid off over the next several months. ## ADORATION BEFORE THE BLESSED SACRAMENT

**HOLY HOUR:** Every 4th Monday of the month at 7:45pm. REPRODUCTIVE HEALTH ACT—This legislation will declare abortion a "fundamental right" in New York State, prohibiting even basic protections, such as parental notification, limits on governmental funding of abortion, and a ban on gender-selection abortions.

The law would allow non-physicians to do abortions, jeopardize any agency that does not refer for abortion and seriously threaten conscience protections for hospitals and medical professionals.

For the sake of pregnant women and their unborn children, we urge our legislators to oppose this bill.

As your constituent, I strongly urge you to oppose the socalled "Reproductive Health Act" S.2524(Klein), S2844 (Stewart-Cousins) that is before the Legislature this session. I understand that this law would, among other things: Remove criminal penalties even from unlawful abortions; Prevent an unborn child who is the intended victim of a crime from being recognized as a victim;

Prevent any limitation on use of taxpayer funds to curtail NY's Medicaid policy of paying for abortion-on-demand through all nine months of pregnancy;

Deceitfully redefine pregnancy as beginning at implantation—not fertilization;

Falsely redefine fetal (child) viability; and

Unleash new assaults on the consciences of those who oppose participating in abortion—health care professionals, hospitals, hospital residents, and health insurance providers. As a citizen and a taxpayer in New York, I am deeply concerned about the future of our state and the effects, intended and unintended, this legislation will have on us who believe that life is sacred and should be protected. ## **FAITH AND NEW WORKS**

STRONG RESERVATIONS AND FIRM CONVICTIONS

Last Friday President Obama announced that he had worked out "accommodations" to respond to the legitimate concerns about religious freedom that Catholic bishops and faithful, along with many others, have been raising to the HHS regulations that mandate coverage of artificial contraception, sterilization and abortion inducing drugs in virtually all health plans as of August 2013. Hopeful as always that truth and common sense would prevail, many of us watched his televised announcement with mounting disappointment. Putting aside some of the President's remarks that reinterpreted what he has actually said to officials of the USCCB (Catholic Bishops Conference), Mr. Obama raised more difficulties than he claimed he had resolved. While there still may be some hope that meetings with Administration officials might clarify some of the issues, the leadership of the US bishops and this Bishop remain disappointed and dissatisfied, determined to continue the effort to protect religious freedom and freedom of conscience not only for Catholics but for all Americans.

Put simply, we Bishops are more convinced than ever that we need rigorous legislative guarantees of religious freedom in the face of this Administration's continued effort to force coverage of religiously objectionable procedures as part of a universal mandate for all Americans regardless of their religious or conscience reservations. Without ironclad guarantees that to date we have not been given, we will continue to work for the repeal of the mandate.

Sometime this week at least part of the President's "accommodation" will appear in the Federal Register. At present we are deeply concerned about the inadequacy of what has been proposed to date. What are our reservations?

The Administration continues to insist on an overly narrow definition of what persons and what institutions can exercise the right of conscience or religious belief. This is problematic on two levels: the definition in itself is objectionable because government has no right to determine what religious beliefs or conscience will be afforded the right of free exercise. The Constitution guarantees this freedom to all. Second, the Administration's narrow definition leaves out untold numbers of persons who would and will be forced to violate their conscience and their beliefs or else be subject to stiff penalties.

It remains unclear how the shift of responsibility to pay for these objectionable products and services from the employer to the insurer will be paid for. The only logical conclusion is that the insurer will pass on the increased costs to the insured and we have the same objection as before; using the force of government to compel insureds to pay indirectly for products and services that violate the tenets of their faith is just as objectionable as compelling them to pay directly for these products and services. It makes sense to offer many women's health services such as mammograms without co-pay. These help prevent disease. But I have yet to discover how pregnancy can be categorized as a disease. In addition, insurers that now offer plans that do not include these objectionable procedures will, if the HHS mandate stands, have no choice but to offer

them. Fidelis Health Care, the largest HMO providing health care coverage for the poor in New York is a Catholic organization that has a corporate membership comprised of the New York Catholic bishops. What happens here?

There are instances in which a religious organization is both employer and insurer. It seems that, notwithstanding President Obama's announced "accommodation", these religiously based institutions, as well as student health plans in Catholic colleges, would have to offer this objectionable coverage. One such self-insured religious body is the Diocese of Rockville Centre.

A whole other category of countless persons who would be forced into violating their consciences would be Catholics and others who operate in the secular sphere or work for secular employers. Catholics who own businesses or those who work in businesses who share our moral objections to such products and procedures as abortifacients are forced by government into compliance without any consideration for their religious convictions or their conscienscious objections.

When these regulations were presented on January 20, we were informed that the churches and religious organizations which would be exempt in the narrow definition of the mandate would be given a "grace period" of one year until August 2013 to find out how we must comply. The President of our Bishops Conference, Cardinal-designate Dolan, referred to this as a year to learn how to violate our consciences. That "grace period" now seems to have been changed to a year long "process" to determine what religious organizations or individuals may or may not qualify for the new "accommodation." This is a grave concern for us Bishops. It reduces a God given right, protected by the First Amendment, to a "privilege" to be negotiated with an Administration that swore to uphold the Constitution of the United States. The HHS mandate and its support by the Administration are deleterious to the life and liberty of citizens who should be able to live secure in the conviction that their right to religious freedom is not being undermined. Indeed, our right to religious freedom must be re-affirmed as soon as possible by all those in our government who have caused this grave situation to surface. The clear assertion of religious liberty is a matter of justice this Administration owes to all Americans.

For all these reasons, I am convinced that we need to pass the Restoration of Religious Freedom Act being sponsored in the United States Senate by Senators Rubio and Blunt and many others. While I await the counsel of those who are far more expert than I, it would not surprise me if we will have to have recourse to the Courts because of the Administration's intransigence. The First Amendment, conscience protection and the right to religious freedom and its exercise are too valuable, too inalienable, too God-given, too essential for human freedom and dignity for us to let this mandate become the law of the land.

#### Dear Brothers and Sisters in Christ:

The season of Lent is an extraordinary moment of grace the Church is called to live every year in preparation for the Sacred Triduum. These Lenten weeks of prayer and fasting and works of charity are all pointed to the solemn holy days of the Thursday Mass of the Lord's Supper, the Friday of His Passion and Death on the Cross and then the exultant moments of proclaiming His Resurrection at the Easter Vigil and Easter Day.

What we will celebrate on those days shapes and informs what we seek to become by conversion, prayer and penance in the Lenten season. At the heart of the Cross of Jesus Christ is forgiveness and reconciliation. As we enter into the season of Lent with our eyes fixed on Jesus, I would like us all to pray for forgiveness of our own sins and pray for the conversion of the hearts and lives of us all so that we may belong more deeply to Christ, to His Church and to one another. As we examine our consciences and as we see ourselves in the light that shines forth from the Cross, I pray we may all receive the forgiveness that only a merciful Father can give us through His Son and through the Church. I pray that we all will seek the healing of our hearts and reconciliation with God that the Church offers through the great sacrament of merciful love, the sacrament of penance and reconciliation.

And I pray that, as we are forgiven by God, we may also forgive one another and be reconciled with one another so that, as the one Body of His Church, we may celebrate the Easter sacraments worthily and with great joy. Sister Mary Hughes, OP, Prioress of the Dominican Sisters of Amityville, wisely shared these thoughts with consecrated women: "Forgiveness never pretends that all was well... Neither does forgiving mean that one does not speak. Make no mistake. It is wrong to have so many fractured relationships in the Church and in our world". She is right! Forgiveness and reconciliation are sorely needed in our Church and in our world. If God forgives us, we too must forgive one another. You know those whom you must forgive. You know those with whom you must be reconciled. Are they in your family? In the Church? In your neighborhood? Near or far away? Now is the time for forgiveness, now is the time for salvation.

On the Cross Jesus cried out to the Father, "Forgive them". That cry was for each and every one of us. This Lent He will whisper that same cry to each one of us: "Forgive them". As He healed a fractured world and a torn humanity making us one with God and one another, I pray we too might help heal any and every fracture in our lives by imitating Him, forgiving one another from a sincere heart, and reconciling ourselves with one another so that His cross might be not only our hope but the hope for all humankind.
